Peach State FCU Stories Contest Official Rules

How to Enter

- Please limit one entry per person. Ten semi-finalists will be chosen; seven finalists and three winners will be selected from that group.
- Limit (1) one entry per person, regardless of the method of entry. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Sponsor (aka "Peach State FCU.") You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules.
